



GENERAL TERMS AND CONDITIONS FOR STALLS

Please read and keep the letter for future reference. ALL the info you'll need is in the letter.

1. EXHIBITORS FEES / CANCELLATION OF STALLS / LATE ARRIVALS

A full payment of the exhibitor's fee is payable, and proof of payment must accompany your application form. No booking will be made without proof of full payment. The application will be placed on a waiting list until proof of payment for the full amount has been received. The closing date for applications is 15 May 2025.

It is the responsibility of the exhibitor to make sure that his stall is reserved and that the proof of payment was received by Horings & Dorings Hluhluwe PTY Ltd. No refunds on cancellations.

Exhibitors who do not arrive at all will forfeit the whole amount paid.

All stalls left with litter will be blacklisted!

2. POSITION OF STALL

Horings en Dorings Hluhluwe PTY Ltd reserves the right to limit the number of exhibitors and products / items sold and no correspondence will be entered regarding the matter. Horings en Dorings Hluhluwe PTY Ltd reserves the right to change the Floor Plan when and where necessary! Horings en Dorings Hluhluwe PTY Ltd will do the terrain layout and allocate stalls according to bookings paid.

3. EXHIBITORS TICKETS

- **NO free tickets. All vendors to purchase R150 vendor weekend tickets.**
- No vendor will be able to access or leave the terrain unless their tickets are shown.
- Only 2 vendor weekend tickets will be available to purchase for 4x4 Stalls
- Only 4 vendor weekend tickets will be available to purchase for 6x6 Stalls.
- Only 6 vendor weekend tickets will be available to purchase for larger Stalls.

- Any Additional tickets for family and friends can be purchased online or at the entrance gate.

4. ACCOMMODATION

Accommodation can be booked at guesthouses & Lodges in Hluhluwe. Please check out the website www.horingsendorings.co.za for accommodation listing. **No camping on site!**

6. EXHIBITORS -GENERAL RULES – PLEASE READ

- 6.1 Exhibitors may only sell the products as listed on their application forms. Please list **everything** you intend to sell.
- 6.2 **No “Bibi guns”, “Blow pipes”, Darts, “Pops” or Fireworks or any other DANGEROUS items may be sold.** All swords and knives must be displayed in a showcase. Once purchased, the items must be securely packed to prevent usage during the festival.
- 6.3 **Exhibitors who do not adhere to rules 6.1 and 6.2 and 6.13 will be forced to stop trading immediately and no refund will be made.**
- 6.4 All exhibitors must be ready to start trading at 14h00 on **30 May 2025**
- 6.5 Only ONE electrical point of 15amp may be used per food stall. Horings & Dorings Hluhluwe PTY Ltd will take no responsibility for any damage to any appliances. People selling food must inform the office well in advance of all the electrical appliances that will be used.
- 6.6 All exhibitors must ensure that they have the necessary licence/permission to sell the product on display in the stall.
- 6.7 Exhibitors are responsible for gazebos / tents, tables, 30m extension cords, double plugs etc.
- 6.8 We want to encourage the food vendors to use gas, where possible. Food vendors cooking with gas, must please remember to have a fire extinguisher on site. If no extinguisher is found during safety inspection, the safety officer has the authority to close the vendor down.
- 6.9 No animals are allowed on the premises.
- 6.10 Evaluation of stalls will start at 14h30 on Friday 30 May 2025
- 6.11 **Stall Hours:**
All stalls:
30 May 2024 – 15h00 – 22h00
31 May 2024 – 07h00 till late - **Food stalls to be open by 07h00**
Vendors will only be allowed to break up their stalls on Sunday morning 1 June 2024.
- 6.12 Security guards will be present during the time of the festival.
Horings en Dorings Hluhluwe PTY Ltd will take no responsibility for any damage or loss of any nature.

6.13 **NO PERSONAL ALCOHOL OR COOLERBOXES ARE ALLOWED ON SITE.**
PLEASE SUPPORT FELLOW VENDORS FOR REFRESHMENTS.

6.14 Access Control

- No Vendor will be able to access or exit the terrain unless they can show their entry Ticket.
- No vehicles are allowed on the premises.
- Vehicles will only be allowed in, when you are putting up your stall, and breaking up your stall. Vehicles must be outside premises by 14:30 on Friday, 30 May 2025. Parking will be allocated to Vendors.

6.15 Exhibitors are requested to treat the public with respect and dignity (they are after all the customers). The use of unacceptable (foul language, suggestive or controversial comments) tactics to lure the public to your stall will not be tolerated under any circumstances.
